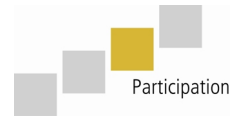

Scenario 2	If a Kick Out Event has occurred , the Investor will receive the Underlying, taking into account the Conversion Ratio.
Settlement Price	Official closing price of the Underlying on the Expiration Date on the Relevant Exchange, as determined by the Calculation Agent.
Kick Out Event	A Kick Out Event shall be deemed to have occurred if at any time during the Observation Period the price of the Underlying trades at or below the Kick Out Level. (Regular trading hours on regular trading days apply.)
